## Accountability of Sails in the ORCsy Rule

## 2020 Changes





Since the debut of the ORCsy rating system, both the rule and VPP have been modified annually as the ORC learned more about superyacht sailing characteristics. All superyacht racing programs should be aware that there are meaningful changes to how the 2020 rule accounts for sails.

In March 2019 the SYRA Fair Racing/Handicapping Committee formed a Working Party consisting of 15 individuals who collectively possess a significant amount of experience and expertise with superyacht racing and sails. This group looked very carefully at all aspects of sail accountability. They then met with the ORC and presented their suggestions on how to improve this component of the rule. The goal was to make the racing fairer, all the while keeping the needs and desires of the yacht owner at the forefront.

The ORC accepted the SYRA recommendations. Some of the more meaningful changes include:

- Yachts declaring to ORC the sails to be used are for *an entire regatta*, as opposed to sails to be carried *aboard for any one race*. This will eliminate the practice of drawing from an unlimited number of headsails and spinnakers over the course of a regatta. All declared sails will not have to be onboard the yacht for all races in the series.
- Percentage penalties for the number of headsails and spinnakers declared start with no penalties for 2 headsails and 2 spinnakers in the inventory. Penalties and credits will be as follows:

## Headsails

No penalty for 2 headsails 0.5% penalty for each headsail in excess of 2 0.5% credit for yachts with furlers

## **Spinnakers**

No penalty for 2 spinnakers 1.0% penalty for a 3<sup>rd</sup> spinnaker 0.5% penalty for each spinnaker in excess of 3

- The use of RIBS or support boats for transferring sails will be prohibited. Sails to be used for the
  day's racing must be onboard the racing yacht before it leaves the dock or mooring for the race
  course.
- Page 2 of the ORC Certificates will list all declared sails with maximum sail dimensions included.

Regardless of whether an organizer invokes Category 4 under their regatta rules, if a 'Heavy Weather Jib' is included in a yacht's inventory (surface <0.135\*IG^2), it must be declared and carried onboard for all races in the series. On the contrary, a Storm Jib (surface<0.05\*IG^2) shall not be accounted for in the inventory and so shall not be declared.
